1 WHAT IS AI-BOOST?

<u>Al-BOOST</u> is an **EU-funded prominent open challenge prize program** that will serve as a benchmark for the European artificial intelligence (Al) community.

The overall objective of the project is to create and run highly replicable **open AI innovation** competition that attracts outstanding talent all over EU and Associated Countries to drive scientific progress in the major AI Areas. The project will foster collaboration between the key stakeholders in AI community to define attractive AI challenges with the potential to lead trustworthy and human-centric real-world solutions.

- A unique sound methodology capable of defining high social impact AI challenges.
- A highly replicable and attractive Al open innovation competition capable of leading breakthroughs in technologies and solutions with substantial scientific progress.
- Provide access to infrastructure and expert knowledge and promote its adoption through effective training and troubleshooting during the challenges implementation.
- Attract outstanding talent and the best research teams to tackle AI challenges.
- An Al community to foster interaction among all relevant stakeholders.

2 EXPRESSION OF INTEREST FOR CHALLENGE OWNERS

2.1 CONTEXT AND OBJECTIVES

The AI-BOOST project invites organizations from the private and public sectors to become **challenge owners** of the AI-BOOST Gen AI Innovation Challenges.

Challenge owners are encouraged to propose **real-world**, **high-impact challenges** that can be tackled by European innovators, researchers, and start-ups through the application of **Generative Artificial Intelligence (GenAl)**.

This Expression of Interest (EoI) aims to identify and select relevant, ambitious, and feasible challenges to be solved in the AI-BOOST competition and serve as the foundation for upcoming open innovation competitions across Europe.

The competition will be open to all sectors and application domains, while prioritising those strategically aligned with the EU's Apply AI Strategy and the GenAI4EU initiative (notably healthcare and pharma, manufacturing, mobility, energy, telecommunications, and public services).







2.2 BENEFITS FOR CHALLENGE OWNERS

By joining AI-BOOST as **challenge owners**, organisations will become strategic actors in shaping the next generation of European AI innovation.

Participation offers both **visibility** and **strategic advantages**, including opportunities for innovation, collaboration, and talent engagement.

3 ELIGIBILITY CONDITIONS

Eligible challenge owners include:

- Private companies of any size, such as large enterprises or corporates;
- Public organisations, such as agencies, utilities, or local authorities;
- Non-profit or research entities with relevant expertise.



Guidelines for Challenge Owners





Collaborative challenges are also eligible — for example, a setup where one entity defines the challenge while another provides the data.

To be eligible, challenge owners must:

- Be legally established in an EU Member State or Horizon Europe Associated Country;
- Propose a real, well-defined problem that can benefit from a GenAl-based solution;
- Demonstrate commitment to supporting the challenge by providing relevant data, mentoring, infrastructure, or other in-kind resources during the competition phases.

4 WHAT CHALLENGE OWNERS PROVIDE?

Challenge owners are expected to:

- Submit a Challenge Description using the official AI-BOOST Challenge Template;
- Provide access to data or test environments, where relevant;
- Participate in co-creation and mentoring during the competition phases;
- Contribute monetary or non-monetary prizes (e.g. hosting demonstrations, offering internships, or access to facilities). See more information regarding non-monetary prizes in the following link: Non-monetary Prizes - AI-BOOST

5 HOW TO APPLY?

Challenge owners are invited to send the required documentation via email to the following address: info@aiboost-project.eu

Challenge owners need to send the following documents:

- Annex 1 Company description (1 page max): an overview of the applicant organisation, including its main activities and relevance to the proposed challenge, and the reasons for its interest in submitting this challenge.
- Annex 2 Challenge description (1 page): a brief description of the proposed challenge, completed using the official template provided at the end of these guidelines.

Both documents must be sent in PDF format within a single email message with email subject line: Challenge Owners EOI – [Name of Organisation].

An acknowledgement of receipt will be sent to each applicant.

English is the official language, submissions done in any other language will not be taken into account.

6 SELECTION PROCESS









Challenges will be accepted and reviewed on a first come, first served basis, until the available slots in the AI-BOOST Challenge are filled.

Submissions will be assessed by the project consortium to ensure relevance, feasibility, and alignment with the objectives of AI-BOOST and Apply AI Strategy.

Results will be communicated by the official email of the AI-BOOST project.
